RELEASE & WAIVER OF LIABILITY, ASSUMPTION OF RISK & INDEMNITY AGREEMENT

In consideration of participating in all activities with Navarre Youth Sports Association (NYSA), I represent that I understand the nature of this activity and that I am qualified, in good health and in proper physical condition to participate in such activity. I acknowledge that if I believe event conditions are unsafe or I am unable to safely perform any activity, I will immediately discontinue participation in the activity.

Parental Consent: I hereby covenant and promise that I am the minor's parent and/or legal guardian, and on behalf of myself and the minor, understand the nature of the above referenced activities and the minor's experience and capabilities and believe the minor to be qualified to participate in such activity. I further understand the risk of exposure to injury and/or infectious diseases, for myself and my child, as a participant, spectator at events, training sessions, and/or games at the NYSA complex. I hereby release, discharge, covenant not to sue and AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS NYSA together with its agents, representatives, employees, coaches, and/or officers from any and all liability, claims, demands, losses or damages on the minor's or my account that are in any way related to or arising from participation in the activities contemplated herein, including, but not limited to injury, negligent rescue operations, and/or exposure to infectious diseases. I further agree that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claim against NYSA, its agents, representatives, employees, coaches, and/or officers, I WILL DEFEND, INDEMNIFY, AND HOLD HARMLESS each from litigation expenses, attorney fees, loss liability, damage, or cost which any may incur as the result of such a claim.

I further acknowledge, understand, appreciate, and agree that my participation and my child's participation may result in possible exposure to and illness from infectious diseases, including, but not limited to MRSA, Influenza and Covid-19 (Coronavirus). While guidelines and social distancing may reduce this risk, the risk of serious illness and death does exist. I knowingly and freely assume all such risks on behalf of myself and my child, whether such risks are known and unknown, even if arising from negligence of others, and I assume full responsibility for my participation and my child's participation and exposure. No one can ensure that COVID-19 is not present at the NYSA complex, gym, football fields, baseball fields, soccer fields etc. As with the transmission of any communicable disease like a cold or the flu, I understand that persons may be exposed to COVID-19 at any time or in any place. Despite the continued careful attention of the NYSA to personal protection and disinfection protocols to limit transmission of this disease, there is still a chance that persons could be exposed to this or other illnesses within the confines of the NYSA (park/complex).

I have read the RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, and I understand that I have given up substantial rights by signing it and have signed it freely and without and inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law. I agree that if any portion of this Agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
